

Declaration on information obligation

(Data protection)

The protection of your personal data is very important to us. We process your data therefore exclusively on the basis of the legal regulations (GDPR). In this privacy policy we inform you about the most important aspects of data processing within our website.

Contact us

If you contact us via the form on the website or by e-mail, your data will be stored for six months to process the request and in case of follow-up questions. We will not share this information without your consent.

Cookies

Our website uses so-called cookies. These are small text files that are stored on your device with the help of the browser. They do no harm.

We use cookies to make our offer user-friendly. Some cookies stay on your device until you delete it. They allow us to use your browser to recognize your next visit.

If you do not want this, you can set up your browser to let you know about informed cookies and you allow this only in individual cases.

Disabling cookies may limit the functionality of our website.

Web analytics

Our website uses functions of the web analytics service Google Analytics (https://www.google.com/intl/de_at/analytics/features/analysis-tools.html). These are cookies which allow an analysis of the use of the website by your users. The result generated information is transmitted to the server of the provider and stored there.

You can prevent this by setting up your browser so that no cookies are stored.

Your IP address is captured but immediately pseudonymized. This is just a rough localization possible.

The relationship with the web analytics provider is based on standard contract clauses / one appropriateness decision of the European Commission.

The data processing takes place on the basis of the legal regulations of the § 96 exp. 3 TKG (Austrian law) as well as Art 6 (1) (a) (consent) and / or f (legitimate interest) of the GDPR.

Our concern within the meaning of the GDPR (legitimate interest) is the improvement of our offer and our website. Since the privacy of our users is important to us, the user data will be pseudonymized. The user data is kept for a period of 6 months.

In order to provide you with targeted information, we also collect and process voluntarily provided information on areas of interest and postal code.

Your rights

You have the rights to information, correction, deletion, restriction, data portability, revocation and opposition to. If you believe that processing your data violates the data protection law or your data protection claims otherwise in have been injured in any way, you can complain to the regulator.
